Legal Updates

How much can my rent increase in 2022?

The rent increase guideline for 2022 is **1.2%**. This is the maximum amount your landlord can increase your rent without approval from the Landlord and Tenant Board. It's possible that you *may* receive a notice to increase your rent in 2021, however the earliest it can take effect is January 1, 2022 because the rent increase guideline for 2021 is 0% - in other words, rents are **frozen** from January 1 to December 31, 2021. However, **there are some exceptions to the increase**. Certain units are not covered by the guideline, such as subsidized units and some newer units.
